# TRANSIT STUDY AND DRAFT ENVIRONMENTAL IMPACT STATEMENT (DEIS) SUBMITTED TO AGENCY SCOPING MEETING APRIL 26, 2006

The University of Wisconsin-Madison was an active member of the advisory committee to the alternatives analysis for potential commuter rail in Dane County and is currently a member of the Implementation Task Force for Transport 2020. We are strong supporters of this project since commuter rail could serve a key role in our overall parking, transportation, and transportation demand management plans and operations.

With over 60,000 faculty, staff, and students, the University campus community constitutes the single largest employer and destination for commuters, including transit commuters, in the Madison metropolitan and Dane County area. The implications of this fact for the scope of the Draft Environmental Impact Study (DEIS) are powerful. First, the study should ensure that any potential commuter rail adequately serve the University's commuters both within the City of Madison as well as at and beyond the periphery of Madison where an increasing number of our staff and faculty reside as the region expands. The University would be happy to provide geo-coded data describing the residential locations of the campus community as well as information about the daily schedules of our faculty, staff, and students as needed. The peak hours for campus commuting are similar to but not identical to regional averages, especially in the case of faculty and students.

Second, we are concerned that the travel modeling used to assess ridership for alternative commuter rail systems be sensitive to the specific location, populations, and modal characteristics of the campus. Four-step models using relatively large traffic analysis zones (TAZs) can fail to adequately assess concentrated populations such as ours if special care is not taken. Third, the University has already chosen three sites for potential commuter rail stations within the campus as part of its master plan process and as part of the earlier Transport 2020 alternatives analysis. We ask that these stations—at the UW Hospital, Randall Ave. and the Kohl Center—be fully incorporated into the current DEIS process.

With respect to University requirements and permitting, we would point out that all improvements and changes on University property, especially those requiring state funding, must be approved through an established set of University entities and procedures. Entities involved could include the Campus Planning Committee, Campus Transportation Committee, Joint West Campus Area Committee, Joint Southeast Campus Area Committee, the Chancellor, Board of Regents, State Building Commission, Division of State Facilities, and other entities. More information about University approvals as well as easements and related arrangements can be provided as necessary and as the DEIS and preliminary engineering design work proceeds.
